He is a member of the American Physical Society, Southeastern Section of the American Physical Society, American Association of Physics Teachers, Sigma Pi Sigma, Knoxville Science Club (past president), and the Tennessee Academy of

Science.

On May 27, 1942, James White was married to Miss Julia Sanders Taylor of Winnabow, North Carolina. They have three children: James W. White, Jr., age 7; J. Harvey White, age 4; and Charles Pomeroy White, age 2.
