At least one author must be a member of the Tennessee Academy of Science. Regular and student memberships are available for those interested in becoming members. Abstracts will be published in an upcoming issue of the *Journal of the Tennessee Academy of Science*. Publication is contingent on presentation at the Annual Meeting.

Student presenters will automatically be considered for the Student Award Competition.

Format for Abstract Submissions**

Instructions for Titles, Authors, Affiliations and Abstracts:

1. **TITLE:** Type the title in sentence case (capitalize first word and all proper nouns), followed by a period.
  - **Examples:**
    - Incidence of *#Salmonella#* in turtles at the Dunbar Cave State Natural Area, Clarksville, Tennessee.
    - Home range and habitat utilization of white-tailed deer in western Tennessee.
    - Mesophase structure of columnar liquid crystals.
    - The effects of unilateral versus bilateral carotid body denervation on respiration.
2. **AUTHORS:** Type the first name, middle initial (if desired), and last name of each author. Do not include academic degrees.
  - Indicate student author(s) with an asterisk following the name(s).
  - **Examples:**
    - Don C. Dailey
    - John R. Ouellette\*, Devlin S. Fung, and Michael L. Kennedy
    - M. Sarkar\* and N. Spielberg
3. **AFFILIATIONS:** Type the official name(s) of the academic institution, city, and state (no abbreviations).
  - **Examples:** Follow the examples below for multiple authors and multiple institutions.
    - *Single or multiple authors, single institution:*
      - *Austin Peay State University, Clarksville, Tennessee.*
    - *Two authors, two institutions:*
      - *Tennessee State University, Nashville, Tennessee, and Kent State University, Kent, Ohio.*
    - *Multiple authors, multiple institutions:*
      - *Austin Peay State University, Clarksville, Tennessee (JB, DO), and Medical College of Wisconsin, Milwaukee, Wisconsin (PM, HF).*
4. **ABSTRACT:**
  - The abstract should state concisely the purpose, objectives, results, and conclusions.
  - The abstract text (excluding title, author, and affiliation) should be written as a single paragraph not to exceed 150 words.
  - Do not include literature citations or diagrams.
5. **FORMATTING:**
  - Scientific names in title and abstract should be indicated as *# scientific name#*.
  - Unique symbols not supported by the online form should be communicated to the Section Chair.
